Four Rivers Helps Partners Weather the COVID-19 Storm


Like so many of our counterparts, Four Rivers staff quickly moved to working remotely, conducting meetings

via Zoom and similar platforms, hosting webinars and online training, and convening our committee members together despite the challenges of working from home. Four Rivers would especially like to thank Hope Stewart, our website content writer, whose numerous blog posts have shared much-needed resources with our stakeholders, and Jody Christian, our Communications Coordinator, whose

whose graphic design skills have transformed our online presence with powerfully-appealing images. At the same time, our Story Project continued with a new video, "Experience the Wooden Boat Models of South County," shot before the pandemic but finished and posted on April 30. Our work with Anne Arundel County Cultural Resources Division to develop a Boundary Amendment proposal also continued, although the in-person visits to sites have had

to be postponed. We expanded the listings on our website to include virtual experiences (see below), and continued to work in partnership with our Destination Marketing Organization (DMO), Visit Annapolis and Anne Arundel County, to make our heritage tourism efforts more effective (see our interview with Acting Executive Director, Dani Bottcher, also on our website.) In addition, our collaborative event, Maryland Day Celebration 2020, was canceled only one week before its

opening day, but our partners have creatively pivoted to a "rebooted" event entitled "Maryland Day: Unpaused." We appreciate the many local, unheralded heroes who have worked together to weather a difficult and unforgettable challenge with tenacity and optimism, and salute the spirit of collaboration and partnership that makes our area so worthy of a visit, virtual and in person, as we reopen to the public.

MHAA Offers Emergency Grants and Financial Relief to Heritage Nonprofit Organizations

On May 18, 2020, the Maryland Heritage Areas Authority (MHAA) awarded a "first round" of Emergency Grants to nonprofit heritage organizations located in Maryland's 13 Certified Heritage Areas. Fifty-nine matching grants totaling \$600,440 were awarded statewide; a total of \$50,000 in Emergency Grant funds was awarded to organizations in the Four Rivers Heritage Area. The grant funds support emergency operating costs that will help keep these nonprofit organizations afloat, as the COVID-19 public health crisis and the associated economic ramifications continue.

According to Jennifer Ruffner, MHAA Administrator, "This was one of the hardest grant review processes that we have ever participated in, with many worthy organizations in great need of support going un-funded, and the applications are still coming in." She clarified that unless an applicant was determined to be ineligible, they will be considered again for funding in a future grant round, if additional funds become available in FY 2021. Awarded organizations

within the Four Rivers Heritage Area include:

- Annapolis Maritime Museum and Park, in Annapolis
- Captain Avery Museum, in Shady Side
- Historic Annapolis, Inc., in Annapolis
- Historic London Town and Gardens, in Edgewater

In addition, MHAA offered additional financial relief to organizations holding existing grants; not only were project deadlines extended, but an emergency policy allowed that unspent grant funds could be reallocated to an organization's operating costs, as another means of financial relief for struggling sites. This move was unprecedented for MHAA, which acted quickly after early survey responses revealed a growing need due to closed doors, canceled events, and postponed fundraisers. Many thanks to all, and especially to MHAA staff, Jennifer Ruffner and Ennis Smith, for crafting proposals and achieving approvals that brought much-needed relief to many of Maryland's challenged heritage organizations.

"Maryland Day: Unpaused" Events Support Partners Affected by COVID-19

The Maryland Day Celebration event, originally scheduled for March but postponed due to the COVID-19 pandemic, is now back, as our partners strive to offer entertaining and appropriate events during the month of June. This new collection of events is called "Maryland Day: Unpaused." The first phase of the "Unpaused" events will take place June 5-29; additional events remain to be scheduled later in the year. These new experiences include new online content, virtual experiences, recorded lectures and presentations, and outdoor venues that are ready to invite the public to safely return. The Maryland Day Celebration is funded by the Four Rivers Heritage Area and our funders (MHAA, the City of Annapolis, and Anne Arundel County), and participating venues to highlight our historic, natural, and cultural sites.

Accessibility Workshop Recording Available

On Tuesday, May 12, Four Rivers hosted a webinar entitled, "Strategies for Making Heritage Sites Accessible." The webinar featured Robert Forloney, Program Developer & Cultural Institution Consultant, who led a discussion on the key aspects of planning for accessibility, the ethical and legal requirements of ADA compliance, strategies to serve audiences with special needs, the WHY of planning for all audiences, and how these efforts can improve the visitor experience for all. The webinar was recorded, and is available to view on Four Rivers' YouTube Channel.

Robert Forloney has worked in the museum field for almost twenty years as an educator, administrator, and consultant. He has created accessibility programs for institutions such as the Museum of Modern Art, Museum of the City of New York, South Street Seaport Museum and the Chesapeake Bay Maritime Museum, as well as trained interpreters about methods of engaging visitors with different needs. Working with educators at the Metropolitan Museum of Art and the Museum of Modern Art, he coordinated a group called the Museum Access Consortium.
