# 2020 Year in Review

For Four Rivers (and the world,) the Year 2020 is divided into two periods: Pre-COVID and Post-COVID. Prior to March 13, the Four Rivers Heritage Area conducted normal operations, convened committee meetings, formu-

lated grant requests for FY2021 operations and projects, and assisted numerous heritage partners in consideration and submission of grant proposals to FY2021 Maryland Heritage Areas Authority grant round. Fourteen projects submitted "Intent to Apply" forms by January 31, and 12 final MHAA FY21 project grants were submitted by partners by the final deadline of February 29, 2020. Five applications were for Capital grant projects, and five were for Non-Capital grant projects, with two additional multi-heritage area grants, for a total of \$748,795 in grant requests. Four Rivers was also a sponsor of the

Maryland State House's very successful community event, "A Celebration of Harriet Tubman and Frederick Douglass," pictured here.

After COVID-19 so greatly impacted the world and so many offices, businesses, and events shut down, Four Rivers moved its operations online, as so many of our partners did as well. Meetings were held via Google Meet and Zoom; a workshop on making our sites more accessible, with speaker Robert Forloney, was also offered virtually. The Maryland Day Celebration, which had to be cancelled in March, was "re-booted" in June with both in-person and virtual



Finally, our Boundary Amend-

ment Project progressed from receiving the completed study from our partners at Anne Arundel County Cultural Resources Division, to site reviews, assessment, and discussion by our Boundary Amendment Committee, to a draft map that was completed in late December. Watch for final refinements as we aim to present a proposal to MHAA in April 2021.
